



Value-Added Services Terms of Business

These terms relate to our 'Value-Added Services' advertising maps programme and shall be updated from time to time. Registered advertisers promoting on the Biofuel Finder Map shall be notified in advance of any updated terms, but non-registered advertisers are advised regularly to review these terms.

By advertising with The Biofuel Finder, you accept your responsibility as a service provider and to our members who may utilise your services.

1. Responsibility of Biofuel Finder

By registering to promote on our map, you are agreeing to these terms. Your services will be marketed on our maps, viewed by our members so they can either enquire or make a request to use your services.

Our responsibility as Biofuel Finder is to display your services on the Biofuel Finder Map. The placement on Biofuel Finder will be managed by a LLB Capital accepts no responsibility for the performance of the website and any impact on the registered advertiser. Biofuel Finder will not be responsible for any subsequent economic, financial, or other loss whatsoever or howsoever arising.

When promoting to Biofuel Finder members, you accept The Biofuel Finder is not responsible for our clients' requests or requirements to use your services. We are just a promoter.

Currently we are offering a free promotion period for Value-Added Service providers to market their business on our map. This promotional offer will be available throughout 2025 and maybe extended after December 2025. Should this service become chargeable after December 2025, there will be a minimum twenty-eight (28) days' notice provided to registered Value-Added Services providers.

2. Responsibility of Advertiser

When advertising your services, you are required to provide:

- a) An accurate description of your services
- b) Contact information
- c) Reliable point of contact for Biofuel Finder members to access your services

You accept as the advertiser to receive communication from the Biofuel Finder team who will verify company information or to notify you that a customer is interested in utilising your services.

3.VAS Map Promotion Period

Companies who register for the free promotion will be notified of any relevant changes' minimum twenty-eight (28) days before they are implemented and what to expect. No payment shall be taken without prior approval or consent.

5. Application

When applying to advertise on the Biofuel Finder maps, we cannot guarantee the approval of your application especially during promotion periods.

Applicants' data will be securely stored in the Biofuel Finder database. Data shall be made available or discarded upon the request of the applicant or advertiser.

The applicant will be kept up to date via Email, SMS or other communication methods on any promotions and news unless they notify the Biofuel Finder that they prefer not to receive such communications.

Applicants who advertise on the maps during the free period may be required to re-enter their credentials and subscribe to paid advert. There will be minimum twenty-eight (28) days' notice of any requirement to move to the paid account.

5. Development and maintenance

To enhance our platform services, we utilise artificial intelligence and machine learning tools for simultaneous translations and improved detection of spam and malware. In our ongoing effort for continuous improvement, we may introduce or remove features, adjust service limits, and launch new services or remove existing services. Registered advertisers will be notified in advance of this change.

6. Content

We recommend advertisers provide pictures or video content to assist with promoting services on the Biofuel Finder map. If you provide us with picture & video content, you are agreeing to provide us permissions to upload the content. If we upload or share content, please make sure when you send it that you have the necessary rights to do so and that the content is lawful.

When supplying content including text, images, audio clips, digital downloads, we may edit this content to fit in our maps which now becomes the property of Biofuel Finder and the advertiser. VAS providers may not extract and/or re-utilise parts of the content of any Biofuel Finder without our express written consent from the Biofuel Finder.

7. Electronic communications

We will communicate with VAS providers electronically in a variety of ways, such as by e-mail, SMS, social media or written notices (contact@biofuelsearch.com) or communicating through the Biofuel Finder.

VAS providers agree that all notices, disclosures, and other communications that we provide VAS providers electronically satisfy any legal requirement that such communications be in writing, unless mandatory applicable laws specifically require a different form of communication.

9. Paid accounts

Biofuel Finder are not currently charging to promote on the maps however once this changes, the Biofuel Finder will offer registered VAS providers the opportunity to pay by card, direct debit or by invoice payment subject to KYC approval. VAS providers will have the right to cancel payment or debit with 28 days minimum notice.

10. Reliability of the platform

We will do our utmost to ensure that availability of the Biofuel Finder will be uninterrupted and that transmissions will be error-free. However, due to the nature of the internet, this cannot be guaranteed. VAS providers access to the Biofuel Finder may also be occasionally suspended or restricted to allow for repairs, maintenance, or the introduction of new facilities or services. We will attempt to limit the frequency and duration of any such suspension or restriction. Biofuel Finder will not be responsible for losses that were not caused by any breach on our part, any business loss including loss of profits, revenue, contracts, anticipated savings, data, goodwill or wasted expenditure or any indirect or consequential losses that were not foreseeable to VAS providers when using the Biofuel Finder.

We will not be held responsible for any delay or failure to comply with our obligations under these conditions if the delay or failure arises from any cause which is beyond our reasonable control.
